**Mrs. Norman advised she wished to press charges, and have Mr. Gilmore trespassed from the business. Mr. Gilmore was advised he was being arrested for shoplifting. Mr. Gilmore was handcuffed behind the back double locked, and checked for fit. Mr. Gilmore was searched incident to arrest, and no contraband was located. Mr. Gilmore was placed in the back seat of patrol car 4260, and transported to the Cartersville Police department.**

**Mr. Gilmore was advised of the criminal trespass warning, and was release on a ROR.**
