On Friday, January 08, 2021, at approximately 0830 hours, I was conducting routine patrol in my marked, issued patrol vehicle, in the area of Wingfoot Trail and Akron St. As I turned right onto Wingfoot Trail, I witnessed a silver Honda CRV driving at a high rate of speed going to wrong direction on Litchfield St.

I caught up to the vehicle, positioned my patrol vehicle behind the CRV (GA TAG) and conducted a traffic stop on the vehicle. The vehicle stopped in front of 21 Cantrell St. and I made contact with the driver, Mr. Michael Ross. Mr. Ross' information was checked through GCIC and returned with a suspended driver's license.

Mr. Ross was taken into custody for driving while license suspended. Mr. Ross was placed in handcuffs behind his back, double locked for safety, and checked for fit. Mr. Ross was searched incident to arrest for contraband or weapons, none were located.

Mr. Ross' vehicle was secured in front of his residence, where the traffic stop was conducted.

Mr. Ross was placed in the rear of my patrol vehicle and transported to the Cartersville PD for processing. Mr. Ross was booked and fingerprinted for Driving while License Suspended or Revoked and released on a ROR BOND.

The rear of my patrol vehicle was search at the start of shift and before and after each transport for contraband or weapons, none were found.

This incident was documented on my department issued BWC.

No additional information was available at the time of this report.
