On Monday, March 1, 2021, at approximately 1322 hours, I was dispatched to a domestic in progress.

I contacted Officer Roth and Officer Calhoun, and advised them to place Mr. Abernathy in handcuffs. Mr. Abernathy was detained, and his items and person was searched incident to arrest, finding no contraband on his person or in his belongings. I proceeded to make contact with Mr. Abernathy, and placed him in the rear of my patrol vehicle. I proceeded to transport Mr. Abernathy to the Bartow County Jail without incident. Mr. Abernathy was relinquished to Deputies for processing. The following warrants were taken out on Mr. Abernathy:

Battery FA (OCGA 16-5-23.1(A))

Obstructing Persons making an Emergency Telephone Call (OCGA 16-10-24.3)

Criminal Trespass (OCGA 16-7-21(B))

I provided the victim with a Cartersville issued case card, and she was provided crime victim's information. My issued marked vehicle was checked at the start of shift, before and after each transport with no contraband located. A Victim Notification Form was filled out and added to the case file. A copy of the warrants was added to the case file. Photos were taken and added to the case file. The incident was captured on my body worn and in-car camera system
