## **OfficerID: HOBBS194, ORIGINAL WRITEUP**

**On Monday, March 1, 2021, at approximately 1738 hours, I was dispatched to 825 West Avenue, Ingles, in reference to a theft in progress. Upon arrival, I made contact with the complainant.**

**Complainant stated the suspect, later identified as Mr. Steve Osborne, took two filet mignon steaks, worth \$9.56 each, from the meat department, took them out of the packaging, and placed them in a bag with his items. I proceeded to the meat department, and made contact with Mr. Osborne. I asked Mr. Osborne if he took any steaks from the meat department, and he stated he did not. I asked Mr. Osborne if I could search his items, and he stated I could. I located one steak in a pharmacy bag with medicine. I asked Mr. Osborne where the other steak was, and he stated he did not have another steak. I observed Mr. Osborne continually reaching into his right hand pocket, and I asked to search it. Mr. Osborne gave consent, and I located the other steak inside of the right pocket.**

**Photos were taken and added to the case file. A warrant was taken out on Mr. Osborne for Shoplifting (OCGA 16-8-14), and a copy was added to the case file. A victim notification form was completed and added to the case file. The incident was captured on my body worn camera system.**
