**On Tuesday, March 03, 2021, at approximately 2221 hours, I responded to 674 S Tennessee St in reference to a Cardiac Arrest (2021-3565), along with Officers Lingerfelt, Gray, and Sanders.**

**While on scene, I heard a vehicle approaching and a loud revving of an engine. I observed a silver Mustang slow to almost a stop at the direction of Officers Gray and Lingerfelt. I heard the engine rev up, and observed the vehicle accelerate suddenly towards both Officers. Officer Lingerfelt jumped out of the way while Officer Gray was struck in the shins before he could fully move out of the way. The mustang continued towards me and came to an abrupt stop.**

**Mr. Daryl Thurman quickly got out of the vehicle and attempted to gain access to the cardiac arrest individual. Mr. Thurman was placed onto the hood of his vehicle and handcuffed. Mr. Thurman continued to resist throughout this process.**

**Mr. Thurman was searched incident to arrest and was negative for weapons or contraband. Mr. Thurman was transported to the Bartow County Jail by Officer Sanders.**

**Warrants were obtained on Mr. Thurman for Aggravated Assault on a Law Enforcement Officer X2, Simple Battery, Felony Obstruction X2, and Misdemeanor Obstruction X4.**

**The vehicle was left on scene at the request of Mr. Thurman.**
