On Thursday, April 29, 2021, at approximately 2208 hours, Lieutenant Ibarra stopped a white 2002 Mitsubishi Lancer at Joe Frank Harris Parkway at Old River Road, traveling at high rate of speed in the area of Joe Frank Harris Parkway and South Bridge Drive.

Lieutenant Ibarra made contact with the driver, Ms. Jennifer Reynolds, who gave the name of Nicole Reynolds and a date of birth of x. A GCIC check of the name Nicole Reynolds yielded that the name was not in the system. Bartow Dispatch advised me that the name Ms. Nicole Reynolds gave was an alias for a Jennifer Reynolds, who had an active warrant through Suwannee County Sheriff's Office for probation violation on the original charge of forgery. A GCIC check of the name Jennifer Reynolds had a suspended drivers license.

I asked Ms. Nicole Reynolds to step out of the vehicle. I placed Ms. Nicole Reynolds into handcuffs to the rear. The handcuffs were checked for fit. Ms. Nicole Reynolds was searched incident to arrest with no contraband located. I explained to Ms. Nicole Reynolds that she may have an active warrant. While searching Ms. Nicole Reynolds, I located a debit card in her front pocket in a apron. I asked Ms. Nicole Reynolds who the debit card belonged to, due to it having the name "Jennifer Reynolds" on the back side. Ms. Nicole Reynolds stated that it belongs to her sister after me finding it in her pocket and saying that "it was just her debit card."

Cartersville Dispatch was able to provide me with a drivers license picture of Ms. Jennifer Reynolds. The picture that Cartersville Dispatch provided me, matched Ms. Nicole Reynolds.

I asked Ms. Nicole Reynolds if her name was really Jennifer Reynolds and she stated that it was. Cartersville Dispatch then confirmed that warrant.

Ms. Jennifer Reynolds stated that she knew that her drivers license was suspended and she used her sisters name. Ms. Jennifer Reynolds was placed into the rear of my patrol vehicle.

Ms. Jennifer Reynolds was transported to Bartow County Jail without incident. My issued marked vehicle was checked at the start of shift, before and after each transport, with no contraband located.

A copy of Ms. Jennifer Reynolds warrant was attached to the case file. A copy of Ms. Jennifer Reynolds' drivers history was attached to the case file. Warrants were secured for Ms. Jennifer Reynolds for giving false name and date of birth, as well as driving on suspended drivers license. Copies of the warrants were scanned into the case file. The incident was captured on my department issued body worn camera and in car dash camera.
