On Friday, April 30, 2021, at approximately 1735 hours, I was dispatched to 19 Puckett street, in reference to an unknown problem.

I proceeded to the Cartersville Police Department to enter evidence and take warrants. The following drugs and drug related items were entered into evidence:

- 14.3 grams of suspected bath salts**
- 15.8 grams of Methamphetamine**
- .0 grams of suspected acid**

- 4 grams of suspected heroin
- 2.2 grams of Marijuana
- One brownie (Weighing 80.3 grams) with suspected THC
- One Oxycodone pill
- Ninety-Two Alprazolam tablets
- One Bong with suspected Methamphetamine residue
- One scale

The bong and scale were entered into evidence, and the narcotics were entered into evidence to be sent to the GBI for testing. The following warrants were taken:

- CE-0145643: Possession of Schedule II controlled substance (F)
- CE-0145644: Possession of Schedule IV controlled substance (F)
- CE-0145645: Possession of Methamphetamine (F)
- CE-0145646: Possession and Use of Drug Related Objects (M)
- CE-0145647: Possession of Methamphetamine with intent to distribute (F)
- CE-0145648: Possession of a Schedule IV Controlled substance with intent to distribute(F)

Further charges are pending on the results from the GBI crime lab. The incident was captured on my body worn camera system. Photos were taken at the scene and at the Cartersville Police Department, and they were added to the case file. A copy of the warrants were added to the case file. A copy of the GBI submission form was added to the case file.
