On Saturday, May 1, 2021 at approximately 2011 hours, I responded to 140 South Tennessee Street (Auto Zone) in reference to a male possibly asleep behind the wheel of a White Nissan Pathfinder.

Upon my arrival, I made contact with Mr. James Crymes. Mr. Crymes seemed disoriented and lethargic. I observed numerous scabs to Mr. Crymes face which is indicative of possible heroin use. Metro EMS arrived on scene and treated Mr. Crymes. Mr. Crymes consented to a search of the vehicle. A search of the vehicle yielded a small bag of suspected Heroin in the cup holder of the vehicle. Before I could ask what I found in the vehicle, Mr. Crymes admitted to the substance being Heroin.

Mr. Crymes was placed under arrest for Possession of Schedule 1. Mr. Crymes was handcuffed with his hands behind his back. The handcuffs were checked for proper fit and double locked. Mr. Crymes was searched incident to arrest with no additional contraband found. Mr. Crymes was transported to the Bartow County Jail without incident. My marked issued patrol vehicle was searched before and after each transport with no contraband located.

A warrant was obtained on Mr. Crymes for Possession of Schedule 1. The warrant and photographs taken were added to the case file. The total gross weight of the suspected Heroin was 0.4 grams. The incident was captured on my body worn camera.
