On Sunday, May 2, 2021 at approximately 0142 hours, I was dispatched to 120 South Erwin Street (The Local Bar and Grill) in reference to an accident that occurred in the parking lot. Officer Bohannon was on scene due to working a special detail.

Upon arrival, I made contact with the driver of the at fault vehicle, Mr. Ned Vandiver. Mr. Vandiver was driving a white, Volkswagen Jetta (GA License) and backed into a truck that was parked in the parking lot. Mr. Vandiver refused to provide his name or identification after being asked multiple times. I could immediately detect an odor of an alcoholic beverage coming from Mr. Vandiver's breath. Mr. Vandiver was unsteady on his feet, had slurred speech and glossy eyes. Mr. Vandiver was very repetitive. Mr. Vandiver stated he had one drink. I asked Mr. Vandiver if he would complete some voluntary field sobriety and he refused. Mr. Vandiver was placed in handcuffs behind the back. The handcuffs were double locked and checked for fitting. Mr Vandiver was read Georgia Implied Consent notice for age 21 and over and did not agree.

I transported Mr. Vandiver to Bartow County Jail where he was released to jail staff without incident. My issued marked patrol vehicle was searched at the beginning of shift, before and after each transport with no contraband located.

Mr. Vandiver was charged with DUI-Less Safe and Obstruction X2. Arrest Warrants and the Search Warrant were scanned and attached to the case file. The incident was captured on my department issued body worn camera.
