On Wednesday, May 5th 2021 at approximately 1434 hours I was dispatched to 104 Zena Drive, Bartow County Sheriffs Department in reference to a report for a stolen vehicle.

Upon arrival contact was made with the complainant, who stated that a vehicle was stolen from his work, Enterprise at 804 Joe Frank Harris Parkway SE, by a customer named Arielle Martin.

Mr. Wells stated that Ms. Martin rented a car from their location on February 24th, 2021 and was supposed to return the vehicle a few days later. Ms. Martin has not returned the vehicle and Mr. Wells has been unsuccessful in reaching Ms. Martin to have her return the vehicle. The vehicle was described as a 2019 Gray Dodge Caravan, GA plate, with an estimated value of \$17,000.

Enterprise wishes to press charges against Ms. Martin.

A GCIC entry form was completed and the vehicle was entered into GCIC as a stolen vehicle.

A copy of the rental agreement has been added to the case file and the original copies have been entered into Cartersville Evidence. A warrant has been obtained for Theft by conversion against Ms. Martin and a copy of the warrant has been attached to the case file.
