**On Tuesday, August 24, 2021, at approximately 0346 hours, I was dispatched to 39 Pine Street, in reference to a 911 investigation. Upon arrival, I made contact with Mr. Chase Mateer who stated that one of the other residents had called 911.**

**A GCIC check of Mr. Mateer's name and birth yielded that he had an active warrant through Bartow County Sheriff's Office for failure to appear and a warrant through Gordon County Sheriff's Office for trespassing. Cartersville Dispatch confirmed the warrants.**

**Mr. Mateer was handcuffed to the rear. The handcuffs were checked for fit and double locked. Mr. Mateer was searched incident to arrest with no contraband located.**

**Mr. Mateer was transported to Bartow County Jail without incident. My issued marked vehicle was checked at the start of shift, before and after each transport, with no contraband located.**

**Copies of the warrants were attached to the case file. The incident was captured on my department issued body worn camera.**
