On Wednesday, October 13, 2021 at approximately 2340 hours, I was working an extra duty job at 120 South Erwin Street (The Local Bar and Grill) when a concerned citizen approached me and stated a male in a silver Toyota Tacoma was very intoxicated.

I observed the vehicle pass in front of me and turn East onto Main Street. As I got behind the vehicle I observed the vehicle fail to maintain lane. I then initiated a traffic stop at Main Street at Joe Frank Harris Parkway and made contact with the driver identified as Mr. Michael Cagle. I immediately detected the odor of an alcoholic beverage coming from Mr. Cagle's breath. Mr. Cagle's speech was slurred and incoherent. I asked for Mr. Cagle to exit the vehicle in which Mr. Cagle refused. Mr. Cagle stated he did not have his firearm on him and did not feel comfortable getting out. I asked Mr. Cagle numerous times to step out of the vehicle and each time Mr. Cagle refused to do so. As I was having my conversation with Mr. Cagle, I observed an open container of Twisted Tea in the cup holder of the vehicle. Mr. Cagle was escorted out of the vehicle and detained for further investigation.

Mr. Cagle was read Georgia Implied Consent for subjects age 21 and over and Mr. Cagle refused by stating "Fuck that and Fuck all of y'all". The next on list tow company was contacted and Wayne Martins arrived on scene for the vehicle. Mr. Cagle was placed under arrest for Driving Under the Influence of Alcohol, Obstruction (M), Open Container of Beer, and Failure to Maintain Lane. Mr. Cagle was transported to the Cartersville Police Department to obtain a search warrant. Due to technical difficulties at the police department I relocated to the Bartow County Sheriff's Office to obtain the search warrant. I then experience technical difficulties at the Bartow County Sheriff's Office as well.

Mr. Cagle was released to Bartow County Jail staff for housing. A copy of the warrants was added to the case file. All photographs taken were added to the case file. The incident was captured on my dash camera microphone due to my body worn camera not functioning.
